Glassboro-Camden Line Light Rail Project, Camden and Gloucester Counties, New Jersey

Dear Ms. Alvarez:

This third addendum was completed to reflect revisions that were made to the proposed Glassboro-Camden Line Light Rail Project (GCL) after the submission of the historic architectural reconnaissance survey letter report dated December 5, 2013; the first addendum dated February 7, 2014; and the second addendum dated May 16, 2018. Any changes regarding archaeology will be addressed in the forthcoming Phase I archaeological survey report. The historic architectural Area of Potential Effects (APE) was slightly revised to reflect changes in the project's limits of disturbance (LOD) due to the planned shifting of portions of the existing Conrail track to the west in order to meet current clearance guidelines. The APE was not expanded along most of the widened corridor because: a) it was already wide enough to cover the changes; b) there is a lack of potential direct or indirect impacts due to the presence of major roadways between the new LOD and any buildings; c) the presence of previously identified National Register of Historic Places-listed (National Register-listed)/New Jersey Register of Historic Places-listed (New Jersey Register-listed) or eligible properties that will already have to be assessed for impacts; and/or d) the absence of buildings. The areas where the APE was expanded due to the proximity of buildings to the existing tracks, which are projected to move 7 to 8 feet closer to the buildings, include, from north to south:

- 1) West side of railroad corridor, roughly between Warren Street and Chambers Street 16 additional resources were identified in this area: ADM Survey Nos. 300 to 315.
- 2) West side of railroad corridor, roughly between Market Street and Broadway 15 additional resources were identified in this area: ADM Survey Nos. 316 to 330.
- 3) West side of railroad corridor, roughly between Town Center and Big Timber Creek one additional resource was identified in this area: ADM Survey No. 331.
- 4) West side of railroad corridor, roughly between Dickerson Street and Dare Street seven additional resources were identified in this area: ADM Survey Nos. 332 to 338.

This addendum also serves to update the background research conducted for the original reconnaissance survey and the first two addenda. A review of New Jersey Department of Environmental Protection's (NJDEP's) Geo-Web database revealed that the Railroad Under-Grade Bridge Number 1222 was determined individually eligible for listing in the National Register/New Jersey Register in October 2009. This resource is also being evaluated as part of the forthcoming intensive-level survey of the West Jersey & Seashore Railroad/Pennsylvania-Reading Seashore Lines.

The following documentation is enclosed:

- Inventory of 39 additional aboveground resources within the revised APE (ADM Survey Nos. 300 to 338; Appendix A: Table 2);
- Revised Table 3 (formerly, Table 4 in previous documentation; Appendix A), including resources from the December 5, 2013 report; February 7, 2014 addendum; and May 16, 2018 addendum, showing resources removed by the first addendum (black strike-out) and second addendum (red strike-out);
- Figure 1, showing the revised APE and facilities (Appendix B);
- Figure 2, showing the revised APE, facilities, revisions to the LOD, and resource locations (Appendix B); and
- Photographs of the 39 additional aboveground resources within the revised APE (ADM Survey Nos. 300 to 338; Appendix C).

The addendum was completed by A.D. Marble on behalf of STV Incorporated, the Delaware River Port Authority (DRPA), and New Jersey TRANSIT pursuant to Section 106 of the National Historic Preservation Act of 1966 (36 CFR 800, as amended), the National Environmental Policy Act (NEPA) of 1970 (42 U.S.C. 4321 et seq.), and the New Jersey Register of Historic Places Act. The historic architectural reconnaissance survey and analysis were completed by A.D. Marble architectural historians meeting the Secretary of the Interior's Professional Qualifications Standards for Architectural History.

Historic Architectural Background Research

A.D. Marble architectural historians examined the paper files and Geographic Information System (GIS) database of the New Jersey State Historic Preservation Office (NJ HPO) to determine if any of the previously identified resources had been listed in or determined eligible for listing in the National Register and the New Jersey Register since the 2013 survey report, 2014 addendum, and May 2018 addendum; as well as previously identified but unevaluated resources within the revised APE. The New Jersey Historic Bridge Survey, prepared by the New Jersey Department of Transportation (NJDOT) and A.G. Lichtenstein & Associates, Inc., in 1995 (updated in 2001), was also reviewed. A.D. Marble architectural historians also consulted historic Sanborn Fire Insurance Maps from the 1880s to 1949 and historic aerial photography from the 1930s to 1970s for property information and approximate construction dates.

Reconnaissance Survey Methodology

On August 7, 2013, Elizabeth Amisson of A.D. Marble and Caroline Scott of NJ HPO conducted a windshield survey of the project area to define the APE for historic architecture. In areas where impacts would be limited to the existing right-of-way of the Conrail freight corridor (former West Jersey & Seashore Railroad/Pennsylvania Reading Seashore Lines) and the existing right-of-way of the RiverLINE, the APE is limited to the existing railroad rights-of-way. In areas where there is a potential for direct or indirect (including visual) impacts beyond the existing rights-of-way, the APE is larger to account for all potential impact types. From August to November 2013, A.D. Marble architectural historians conducted a historic architectural reconnaissance survey of all properties within this original APE. Due to project changes, Elizabeth Amisson of A.D. Marble conducted a windshield survey of the project area in December 2013 and January 2014 to define the revised APE for historic architecture and

completed a historic architectural reconnaissance survey of all properties within the revised APE. The project was subsequently put on hold.

With the restart of the GCL project in late 2017 and revisions to the LOD, the APE was again revised. Russell Stevenson of A.D. Marble conducted an architectural reconnaissance survey in March 2018 within the APE of those resources that were constructed between the original cut-off date of 1965 and the new cut-off date of 1968, as well as any historic resources in the areas where the APE was expanded. In August 2018, the LOD for the project was increased in some areas, and as noted above, the APE was expanded in some areas to account for potential impacts. Russell Stevenson conducted a reconnaissance survey of the expanded APE in October 2018. Those areas are depicted on Figure 2 in Appendix B.

The APE, as defined, takes into account all potential impact types associated with the aforementioned project revisions: direct, indirect (including visual), and cumulative impacts. The goals of the reconnaissance survey were: 1) to identify any additional resources within the APE that were constructed in 1968 or earlier; and 2) to identify resources potentially eligible for listing in the National Register and New Jersey Register that may be affected by the proposed project. The year 1968 was used as the cut-off date for identification of resources age 50 years or older due to the projected environmental impact statement (EIS) completion scheduled for 2018.

Results and Recommendations

No resources previously identified as part of the original reconnaissance survey or the first two addenda were removed from the study, as there have been no decreases in the APE. As previously noted, the expanded LOD resulted in an extension of the APE in the areas where there are buildings in close proximity to the existing track, which is projected to be moved 7 to 8 feet closer to those buildings (Appendix B: Figure 2, Map Sheets 3 to 6).

NJ HPO records revealed no previously identified historic properties (National Register/New Jersey Register-listed or eligible) located within the revised APE. A.D. Marble identified a total of 39 additional architectural resources that were constructed in 1968 or earlier within the revised APE (see Appendix A: Table 3 for a detailed inventory of all 39 resources). A review of historic maps and aerials, combined with field observations, confirmed the remaining buildings in the revised APE were built after 1968. None of the 39 resources inventoried as part of the reconnaissance survey's third addendum were previously surveyed.

Of the 39 architectural resources documented in this submittal, two are recommended potentially eligible for listing in the National Register/New Jersey Register (see Table 1 below and Appendix A: Table 2):

- ADM Survey No. 316 (Union Cemetery, Powell Street, Gloucester City) is located along the west side of the tracks between Powell Street and George Street. According to signage, the cemetery was established ca. 1840. Although Union Cemetery does not appear to meet Criterion C for its design, an intensive-level survey form for this resource is recommended to determine whether it is eligible under Criteria A or B, as well as whether it meets Criteria Consideration D.
- ADM Survey No. 335 (Presbyterian Church at Woodbury Cemetery, 800 N. Broad Street, Woodbury City) is located along the west side of the existing railroad tracks, across from the N. Broad Street/DuBois Avenue intersection. According to signage, the cemetery was established ca. 1721 with the congregation's original Meeting House, which is no longer on the property. Although the Presbyterian Church at Woodbury Cemetery does not appear to meet Criterion C for its design, an intensive-level survey form for this resource is recommended to determine if it is eligible under Criteria A or B, and whether it meets Criteria Considerations A and D.

The remaining 37 resources are recommended not eligible for listing in the National Register/New Jersey Register due to lack of architectural significance and/or integrity. Please see the enclosed inventory (Appendix A: Table 2), associated mapping (Appendix B), and photographs (Appendix C) for more detailed information on all of the surveyed resources within the revised APE identified as part of this third addendum.

We request the NJ HPO's concurrence on the results and recommendations presented in this third letter report addendum to the original reconnaissance survey. A.D. Marble will prepare intensive-level survey forms for the two properties (Union Cemetery and Presbyterian Church at Woodbury Cemetery) requiring additional investigation, as well as the 19 properties recommended for intensive-level survey as a result of the reconnaissance survey (December 5, 2013), first addendum (February 7, 2014), and the NJ HPO response letter to both; as well as the four properties recommended for intensive-level survey as a result of the second addendum (May 16, 2018) and NJ HPO response letter. The intensive-level survey forms, as well as an accompanying letter report with an updated detailed project description, will be submitted to the NJ HPO for review and concurrence. Historic properties may be affected by the proposed project; therefore, a determination of effects analysis will be completed following the intensive-level survey and evaluation phase.






